## **LET'S TALK ABOUT...**

Are backyard trampolines fun or dangerous? Surprisingly, they can be both. With summer here, this is an outdoor activity that your children may enjoy. But, you should take some extra precautions before you allow your children and others to use it.

Make yourself aware of the following guidelines set forth by the Consumer Product Safety Commission:

- Padding should completely cover metal hooks, frame and springs on the trampoline
- Trampolines over 20 inches high are not recommended for children under 6 years old.
- Ladders can not be sold with trampolines to prevent access by smaller children.
- Only allow one person to jump on the trampoline at a time and warn children against doing somersaults on the trampoline.
